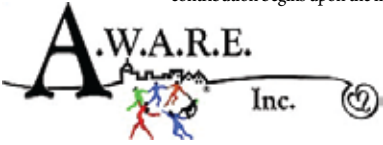

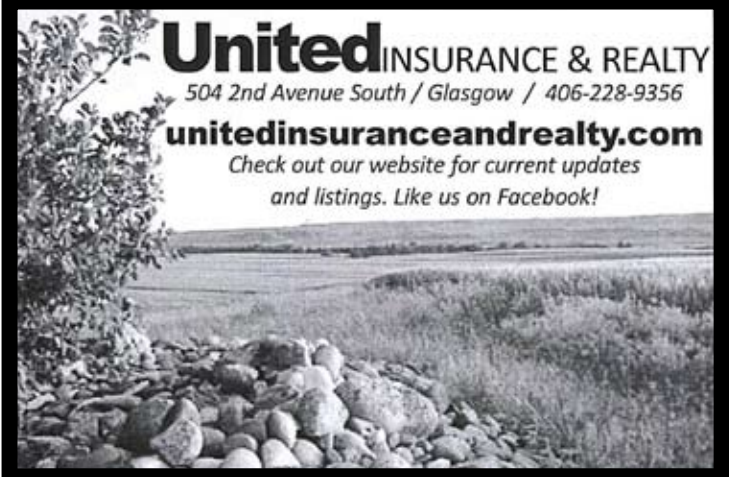

He was an avid fisherman and hunter and enjoyed traveling, cooking, playing cards and hanging out at the VFW and Elks Club in Glasgow.

He and Gigi moved from their home in Saint Marie to Glasgow in about 2005. Frank, our daughter, Cody, and I bought Bill and Gigi's double condo in 2006 and the work they had done on this home was wonderful.

In 2013, we had a knock on the door and Bill and Gigi had come for a visit and to check out the trees she had planted years ago in our backyard, and was amazed at how big they had grown. Bill was very personable and chatted with Frank. Sadly, Gigi and I were talking about Alzheimer's since my dad went through it and Gigi mentioned that Bill was in the first stages of it. Shortly after that visit, we had learned that Bill had moved to Miles City Veterans Montana Health Care System, Community Living Center.
