





Refuse District Fees Rise, Hearing Set for August 7

FOR THE COURIER

At the July 17 Valley County Refuse Disposal District #1 meeting, the board voted to propose an increase in per-unit fees from \$120 per year to \$145 per year. If approved, Valley County residents will see this increase in their No-

vember 2019 tax statement. The last increase in fees was in 2012; this \$25 increase represents a three percent increase per year for the period from 2012 to 2019.

This action was taken to address a \$72,000 shortfall in the budget for the fiscal year 2019. The increase will generate

\$122,500 per year. The decision of the board to increase the fees beyond the expected 2019 shortfall was made in order to not have to raise fees again for several years.

Costs continue to rise in the operation of the landfill, not just due to inflation and increased regulatory requirements, but also due to ever-increasing misuse of the container sites. As more and more residents have dump trailers, the operators of the landfill have seen an increase in dumping of large loads that should be coming across the scale. This increases costs for the landfill in two ways: by loss of revenue that would come from tonnage fees, and increased costs of moving the

The proposed increase must be approved by the county commissioners. There is a public notice posted elsewhere in *The* Courier this week and in next week's issue advertising a public hearing on this fee increase. The hearing is scheduled for Tuesday, Aug. 7, at 11 a.m., in the office of the Valley County Commissioners. The Refuse Disposal District Board and the Commissioners welcome your ideas on the operation of the landfill.
