Montana Administrative Rule ("ARM") 38.5.176 requires utilities to submit a marginal cost of service study ("MCOSS") in each rate case. In its Request, MDU states that it is preparing to file an application to increase natural gas service rates, which would be subject to the MCOSS filing requirement. Request 1-2. MDU asserts that natural gas service costs are driven more by the commodity cost of natural gas than the fixed costs associated with pipeline infrastructure. Id. at 2. As a result, MDU asserts that an MCOSS would not produce useful information and the amount of work required to prepare an MCOSS is not justified. Id. at 2-3. MDU concludes that good cause exists for the Commission to waive the MCOSS requirement of ARM 38.5.176. Id. (citing ARM 38.2.305). MDU also states that it contacted the Montana Consumer Counsel ("MCC"), and MCC does not oppose the request. Id. at 1.
