District's 2021 CCR • In the data tables of this report, you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000. Parts per billion (ppb) or Micro-

grams per liter (ug/L) - one part per billion corresponds to one minute in 2000 years, or a single penny in \$10,000,000. Action Level - the concentration of a contaminant which if exceeded, triggers treatment or other requirements which a

water system must follow.

Treatment Technique (TT) - (mandatory language) a treatment technique is a required process intended to reduce the level of a contaminant in drinking

Maximum Contaminant Level -(mandatory language) The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - (mandatory language) The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no

known or expected risk of health. MCLGs allow for a margin of safety

Nephelometric Turbidity Unit (NTU) - is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Picocuries per liter (pCi/L) - is a measure of the radioactivity in water. Turbidity - is a measure of the

cloudiness of the water. This is monitored because it is a good indicator of the effectiveness of the filtration system. The specified limit for our treatment process is 0.5 NTU's. Each month 95% of our measurements must be below this specified limit. This represents the month with the lowest percentage of a sample meeting this limit. The NVCW&SD, Inc. system has met this requirement 100% of the time. Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

Total Coliform - Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. The Total Coliform Rule requires water systems to meet a stricter limit for coliform bacteria. Coliform bacteria are usually harmless, but their presence in water can be an indication of disease-causing bacteria. When coliform bacteria are found, special followup tests are done to determine if harmful bacteria are present in the water supply. If this limit is exceeded, the water supplier must notify the public by newspaper. television or radio. To comply with the

stricter regulation, we have increased the average amount of chlorine in the distribution system

Fecal coliform/E.Coli. - Fecal coliforms and E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Microbes in these wastes can cause short-term effects, such as diarrhea, cramps, nausea, headaches, oi other symptoms. They may pose a special health risk for infants, young children and people with severely compromised immune systems.

The North Valley County Water & Sewer District, Inc. has monitored for lead and copper, and the samples for the reporting year 2021 have been in compliance with the Lead and Copper Rule.

Elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing Dry Prairie Valley County and North Valley County are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. In an effort to mend this violation, the District has created a 2023 CCR. This "Annual Drinking Water Quality Report" is your copy of the District's 2023 CCR.

• The North Valley County Water & Sewer District, Inc. received a violation for failure to monitor the System for lead and copper for the monitoring period June 1, 2023 through September 30, 2023, in violation of ARM 17.38.216. DEQ notified the District of the lead and copper monitoring violation in letters dated October 17, November 8, 2023. In an effort to mend this violation, the District has immediately started testing for the Lead & Copper Rule.

• The North Valley County Water & Sewer District, Inc. received violations for failure to record and report daily chlorine residuals for the distribution system for the monthly monitoring periods of September and December 2023 in violation of ARM 17.38.225. Additionally, failure to submit its monitoring reports for daily chlorine residuals in the distribution system by no later than the 10th day of the month following the end of the monitoring period for the monthly monitoring periods of January, July, and August 2023, and January, February, March and April 2024, in violation of ARM 17.38.234. DEQ notified the District of these violations in letters dated March 1, 2023, September 18, 2023, February 2, 2024

February 20, 2024, March 29, 2024, and May 15, 2024. In an effort to mend this violation, the District has immediately started chlorine residual testing again and has begun submitting all documents to the Department of Environmental Quality by their appropriate deadlines.

As of this letter writing, the District has begun monitoring again for lead and copper. The results for the 2024 lead and copper monitoring will be posted in the 2024 CCR after the calendar year has completed.
