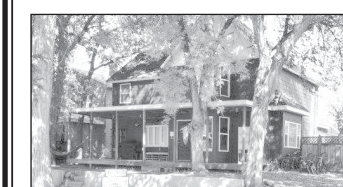

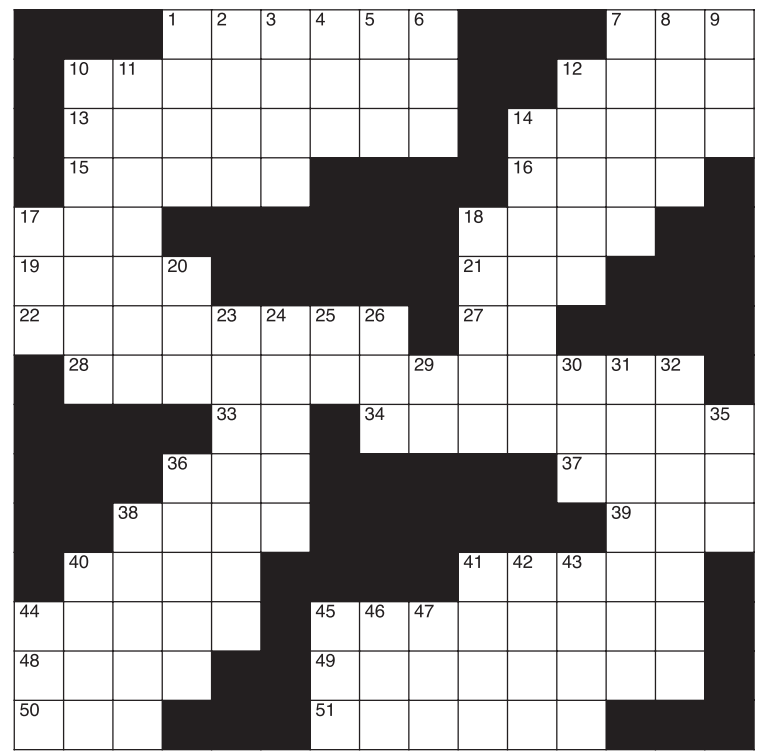

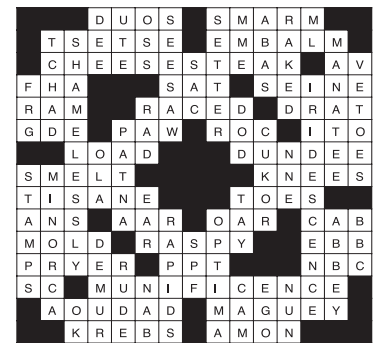

There were 14 motor vehicle stops, two accidental/prank 911 calls, four reports of barking/lost/loose dogs, and one report of loose livestock.

### Monday, November 12, 2018

0852 – A female called in and said she passed a male subject in a green car that is off on the side of the road on the south side. He stepped out onto the highway and was waving his arms. Since she's by herself, she didn't want to stop. She said he would be just east of mile marker 567. Responding deputy was unable to locate the vehicle.

1043 – A woman in St. Marie called in stating she was out in her yard and a black dog with reddish hues came after her and nipped at her. Then, a male was

walking by and the dog went after him. The male had to take his belt off to get the dog away from him.

1552 – The same caller from the above entry called and said that the dog she complained about charged her about 10 minutes ago. She said the dog nipped at her calf but didn't break the skin. viewing situations individually to determine appropriate assistance. The nuts and bolts of Energy Share "happens" with the ten Human Resource Development Councils (HRDCs) across the state, and the volunteer Local Energy Share Committees that each HRDC coordinates.
